The Polk County Land Information Committee met in the County Board Room – 1st floor, Polk County Government Center at 8:30am on Wednesday, April 6, 2011

Present: Supervisors O’Connell, Voelker, Moriak, Brown, and Rattel

Also Present: Gary Spanel, Zoning Administrator; Dana Frey, County Administrator; Tim Anderson, County Planner

Chairman O’Connell called the meeting to order at 8:30 a.m. Proper notice was made of the meeting.

Motion (Voelker/Brown) to approve the agenda – **Motion carried.**

Motion (Moriak/Rattel) to approve the minutes of March 2, 2011 – **Motion carried.**

Public Comment: None

Public Hearings: The Polk County Land Information Committee held a public hearing on April 6, 2011 at 8:30am in the Government Center, Balsam Lake, Wisconsin to consider the following:

- **TROY CRESS** requests a district change from General Purpose to Commercial. Property affected is: US Hwy 63, Lot 3, CSM #5822, Vol 26/Pg 88, in Gov’t Lot 3, Sec 23/T33N/R15W, town of Clayton. Discussion. **Motion (Voelker/Brown)** to postpone any action until the Committee received more information concerning the town’s motion rezoning the parcel Agricultural rather than Commercial. Motion Carried by unanimous voice vote. Hearing closed at 8:45am.
- **RICHARD BUMP** requests a district change from Commercial to Agricultural. Property affected is: NE 1/4 of the SE ¼ and SE ¼ of the SE 1/4 of Sec 9/T34N/R16W, town of Apple River. Chairman O’Connell opened the public hearing for Richard Bump at 8:57am. Discussion. **Motion (Voelker/Rattel)** to approve the district change from Commercial to Agricultural and move it onto the County Board of Supervisors. Motion Carried by unanimous voice vote. Chairman O’Connell closed the public hearing.

Review Final “Schommer Family Plat” Motion (Brown/Moriak) to approve the final plat for “Schommer Family Plat”. Motion carried by unanimous voice vote.

Community Development Block Grant Applications and Project Loans Chairman O’Connell called for a recess at 9:25 am to hold a public hearing to consider two grant applications. Chairman O’Connell called the Land Information Committee meeting back to order at 10:02am. **Motion (Moriak/Voelker)** to approve the two block grants for Engineered Plastic Components, Inc and KAPCO, Inc and to move them onto the County Board. Motion carried by unanimous voice vote.

Preliminary/Final Plat Approval for Roland Belisle Subdivision Motion (Voelker/Brown) to approve the preliminary plat of “Roland Belisle Subdivision”, lots 6-12. Motion carried by unanimous voice vote. **Motion (Voelker/Moriak)** to approve the final plat of “Roland Belisle Subdivision”, lots 6-12 subject to the changes made by the Polk County Surveyor. Motion carried by unanimous voice vote.

Public Hearing (Troy Cress) Motion (Voelker/Brown) to re-open the hearing for Troy Cress at 10:24am, to consider a district change from General Purpose district to Commercial district. Discussion. **Motion (Voelker/Moriak)** to approve the district change for Troy Cress property. Motion carried by unanimous voice vote. Chairman O’Connell closed the hearing at 10:34am.

Town of St. Croix Falls Motion (Voelker/Moriak) to move the two town of St Croix Falls zoning amendments known as Resolution 11-02 (zoning map change) and Ordinance 11-04 (Zoning Ordinance No. 1 amendment) onto the County Board. Motion carried by unanimous voice vote.

Committee Observances Chairman O’Connell said that he received a call from a Board of Adjustment member who inquired about making tourist rooming houses a permitted use.

Update on the Comprehensive Ordinance rewrite was given by Tim Anderson. He informed the Committee that the CAC completed their review of the Comprehensive Land Use Ordinance and will now move onto the Shoreland Protection Zoning Ordinance. The TAG will continue to meet and review the ideas and concerns of the CAC.

Vouchers were reviewed and approved.

Motion (Voelker/O’Connell) to adjourn – **Motion Carried.** Meeting adjourned at 11:03 a.m.
