**Invoices:** The committee reviewed the invoices for the past month.

**Award RFP for Pick-up Bids:** 6 bids were received, discussion. **Motion by Johansen/Brown to award bid to Johnson Motor Sales New Richmond for purchase of 2003 Chevy Silverado 2500K for \$16,995; carried.**

**2011 Goals:** Dave Peterson's goals for 2011 were presented and discussed. **Motion by Rattel/Brown to accept Dave Peterson's 2011 Goals as presented; carried.**
