Called to Order: Joint Meeting at 3:05 PM by Jeff Peterson for REC and Tim Anderson for the EIT

Motion: (JPeterson/Baillargeon) to approve agenda. Carried

Motions: (Westigard/Baillargeon) to approve REC 3/18/10 minutes. Carried  
(Luke/JPeterson) to approve EIT 3/18/10 minutes. Carried

Discussion: Jeff Peterson and Bob Kazmierski explained further why the Renewable Energy Blog could not be put on the county website – Todd Dimmers did not want to set precedent. Arrangements through Bob Kazmierski have been made to post it through the UWEX website/portal.

Discussion: Jeff Peterson and Marlin Baillargeon reported on the substantial progress for the Energy 2010 Fair. Some funds have come in and they are developing many vendors and speakers for the program.

Discussion: Tim Anderson and Bob Kazmierski reported on the April 7<sup>th</sup> OEI meeting at Eau Claire, and the discussion on PACE funding for local businesses and citizens to secure funding for private renewable energy installations. Tim Anderson also reported that he was making very good progress at imputing the county's five-year energy usage data.

Motion: (Westigard/Melin) The EIT will endorse and/or sponsor the Energy 2010 as the Energy Fair 2010 chooses to show on there literature. Carried.

Gregg Westigard affirmed the idea of the joint EIT & REC meeting.  
Kathleen Melin announced the local farmer income meeting at the SCF city hall on 4/15/10.

Jeff Peterson announced the revise purchasing policy is in "hold" status until new county administrator and board are established.
