

**RESOLUTION 32**

**RESOLUTION AMENDING WILD RIVER AREA NO TRESPASSING ORDINANCE**

BE IT RESOLVED that Resolution No. 16 adopted by the Polk County Board of Supervisors on February 23, 1977, be amended to repeal Section I of said ordinance and to create and substitute in its place the following:

**Section I. TRESPASSING IN CERTAIN AREAS PROHIBITED.** It shall be unlawful for any person, other than authorized personnel, to enter onto or remain on any lands which are controlled by Polk County pursuant to the terms of a lease and agreement with Northern States Power Company. Said lands include all lands owned by Northern States Power Company in Sections 6 and 7, Township 34 North, Range 18 West (Town of St. Croix Falls); Sections 1 and 2 of Township 34 North, Range 19 West (Town of St. Croix Falls); Sections 9, 16, 21, 22, 27, 34, 35, and the Southwest Quarter of Section 4 in Township 35 North, Range 19 West (Town of Eureka). Said lands owned by Northern States Power Company are more specifically described as follows:

All lands lying West and South of the River Road and between the River Road and normal high water mark of the East bank of the St. Croix River located in Sections 6 and 7, Township 34 North, Range 18 West (Town of St. Croix Falls), and Sections 1 and 2, Township 34 North, Range 19 West (Town of St. Croix Falls), and in Sections 9, 16, 21, 22, 27, 34 and 35, Township 35 North, Range 19 West, (Town of Eureka). In addition, all of Section 9, Township 35 North, Range 19 West (Town of Eureka) lying East of the River Road except the East One Half of the Northeast Quarter ( $E\frac{1}{2}$  of  $NE\frac{1}{4}$ ) and the East One Half of the Southeast Quarter ( $E\frac{1}{2}$  of  $SE\frac{1}{4}$ ) of said Section 9. In addition those portions of the North One Half of Section 16, Township 35 North, Range 19 West, (Town of Eureka) lying East of the River Road except for the East One Half of the Northeast Quarter ( $E\frac{1}{2}$  of  $NE\frac{1}{4}$ ) of said Section 16. In addition the East One Half of the Southeast Quarter ( $E\frac{1}{2}$  of  $SE\frac{1}{4}$ ) Section 16, Township 35 North, Range 19 West (Town of Eureka).

In addition Government Lots 1 and 2 located in the Southwest Quarter of Section 4, Township 35 North, Range 19 West, (Town of Eureka).

BE IT FURTHER RESOLVED, that the amendment to this ordinance shall take effect upon passage of publication according to law.
